A Capacity Building Programme and Mini Conference'2024 was organized for two days on 20-06-2024 and 21-06-2024 at Tenkasi. Shri.Sunil Mathur, IRS, Pr. CCIT, TN & P was the Chief Guest of the program and it was presided over by Shri.L.Rajasekhar Reddy, IRS, CCIT(TDS), Chennai. This two-days event was organized for Officers of TDS Commissionerates of Chennai and Coimbatore.

The Pr.CCIT highlighted the need to follow the action Plan to achieve the targets, focus on the TRACES data for further analysis, and to replicate the best cases in the respective jurisdiction of the AOs. He also reiterated the need to process the Prosecution cases in a time bound manner, organize Intense Awareness Programs specially for Government deductors in order to ensure TDS compliance. The Pr. CCIT also suggested to submit a proposal to the CBDT for simplification of generation of BIN and also filing of Form 24G for Government Deductors. Similarly, he also suggested that validation of Form 24 G may be incorporated at all levels to avoid fraudulence.

Capacity Building Programme on MS-Excel and MS-Word

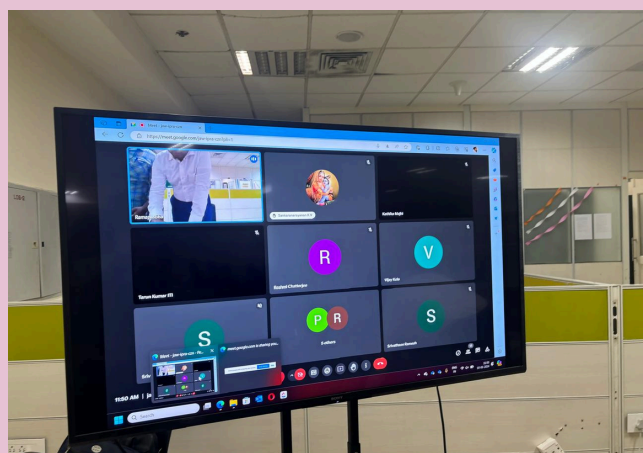
